1. This case was re-opened owing to the fact that a letter dated 23 Dec 58 was received by the Chief Constable Winnipeg Police Dept from the Commandant RCASC School, CAMP BORDEN, Ontario requesting a copy of the police report in this case. It is not of course the policy of civilian police forces to release reports concerning offences of this nature to other than recognized police agencies including service police. However a copy of the statement given by the accused [redacted] to the Winnipeg Police Dept has been forwarded to the CPM, Central Command in duplicate with the request that the OC, Camp Borden Detachment, Central Command Provost Company make the same available to the Commandant RCASC School but retain the report on their own files.
