AUTHORIZED THAT ADMINISTRATIVE RELEASE ACTION BE TAKEN IN CERTAIN SPECIFICALLY DETAILED CONDITIONS. THESE CONDITIONS ARE:

(1) THE MEMBER ACKNOWLEDGES HIS HOMOSEXUALITY AND DND CONSIDERS SUCH MEMBER TO BE HOMOSEXUAL;

(2) THE MEMBER DESIRES TO BE RELEASED FROM THE CF; AND

(3) THE MEMBER DOES NOT OBJECT TO BEING RELEASED UNDER ITEM 5(D) TO QR AND O 15.01 VICE ANY OTHER ARTICLE

B. (PB) IF CPL WRIGHT AFTER BEING BRIEFED ON THE ABOVE ACCEPTS RELEASE FROM THE CF UNDER ITEM 5(D) SUCH RELEASE WILL BE EFFECTED BY NDHQ AS SOON AS ADMINISTRATIVELY POSSIBLE

C. (PB) IF CPL WRIGHT DOES NOT WISH TO BE RELEASED UNDER ITEM 5(D) HE WILL BE RETAINED IN THE CF PENDING RESOLUTION OF THE CF POLICY POSITION. IN THE INTERIM HE WILL BE SUBJECT TO THE FOLLOWING RESTRICTIONS:

(1) NO PROMOTIONS

(2) NO CAREER COURSES

(3) WILL NOT ENTER THE PROTECTED WINDOW

(4) WILL NOT BE REENGAGED, GRANTED IE, IPS, CE OR AN EXTENSION

(5) WILL NOT ADVANCE IN QL


