For your information, however, the following airwomen whose releases were authorized originally for items other than 2(c) submitted Applications for Redress of Grievance. 4 , however, submitted an Application for Redress of Grievance before her release was authorized, assuming that she was to be released under Item 2(c) of QR(Air). On interview with CO; TCHQ who informed her that she was to be released under 5(b)(ii), her application was therefore satisfied and no further complaints were received from her.

5 It is regretted that complete information was not made available to your HQ on these cases, but, it was felt at the time that release action should be effected in the most expedient manner possible for the following reasons:

- (a) The airwomen listed in para 2, by their bad conduct and unnatural tendencies, had been responsible for a situation which was having an adverse affect upon the morale and conduct of other airwomen in the RCAF. Those with unnatural sexual tendencies were contaminating other innocent airwomen wherever they went which would have become more serious the longer they remained in the Service.
- (b) The prestige of the RCAF, if this situation were to become known, would be lowered in the eyes of the public, with a resultant adverse affect on respect for the Service and on airwomen recruiting.

Release under QR(Air), Item 2(c), Inefficiency - Unsatisfactory Conduct - was decided upon, not to punish these personnel, but, to ensure that future enrolment in another Canadian Service would not be possible.
