

SECURITY SCREENING - CHARACTER
WEAKNESSES - HOMOSEXUALITY

1. GENERAL

1. a. The relevance of homosexuality to security can only be judged in its full contextual circumstance. Investigations and reporting therefore must go beyond the simple identification of a person as a homosexual and provide as full an appreciation as possible of how the individual copes with homosexuality.

2. POLICY

2. a. The Security Service shall not collect, report and retain information on homosexuals unless it relates directly to:
 1. the detection, prevention or suppression of subversive or hostile activities, or
 2. security screening pursuant to CD-35.

3. AREA/BRANCH COMMANDER

3. a. Ensure members of your command do not conduct general inquiries relating to homosexuals, their associates, organizations or ~~haunts~~. *meeting places.*
- b. Ensure no general list, file or other record pertaining to ~~homosexuality~~ or homosexuals is created and retained unless the information relates directly to an ~~operating~~ *individual falling within an operating* program or activity of the Security Service.

4. a. Ensure all inquiries and interviews of homosexuals or suspected homosexuals comply with the provision of 2.a. and are conducted with sensitivity, tact, discretion, maturity of judgement and absence of bias.
 1. Report only information relevant to a justified inquiry.
 2. In security screening cases, avoid any personal comment as to whether the individual should be afforded access to classified material.
- b. Where allegations of homosexuality arise during an investigation, e.g. security screening, attempt to the fullest extent possible to obtain independent corroborative information.
- c. When conducting inquiries or interviews, explore fully how the subject copes with homosexuality with emphasis upon whether he or she is embarrassed or secretive about it and if vulnerable to compromise, blackmail or indiscretion.
- d. Provide a full assessment of all sources reporting homosexual information, including the basis for the source's belief.

5. NATIONAL ANALYST

5. a. Include in intelligence assessments relating to homosexuality only those allegations or facts which are fully and factually reported and identification is certain, based on information provided by sources whose reliability has been properly assessed.

5. a. 1. Provide a full explanation and assessment of the vulnerability of the subject due to his or her homosexuality.
- b. Ensure sources, methods of operation and targets of the Security Service are adequately protected in the intelligence assessment.
