1. While I agree that there is considerable discussion of past CF policy on homosexuality in the correspondence between [REDACTED] and the CDS, the particulars of [REDACTED]'s case are not amenable to a policy solution. Therefore, neither I nor my staff can provide the kind of answer requested in the minutes attached to the most recent letter.

2. From my reading of [REDACTED]'s letters, it seems fairly obvious that they constitute claims of injustice and seek, by relatively informal means, some form of redress for a perceived injury. [REDACTED] essentially claims mistreatment by the SIU during the investigation of his homosexual status and reflects some degree of additional hurt and anger resulting from his specific release item (Not advantageously employable) and his loss of security clearance, which are permanently part of his service record. He seems to be asking for some acknowledgement of injury, if not an apology, and an amendment of his records as tangible proof of the CF's commitment to individual rights. There is, then, a question of the CF's legal obligation and moral obligation to [REDACTED]'s statement of grievance. In my view, DPLS should take the lead in recommending a course of action, with case-history input from DPCAOR as appropriate.
